Having undertaken and completed a comprehensive review and evaluation of each curriculum, KU has concluded that students completing qualifying CTE courses with a grade of B or better, will be eligible to receive college credit for related courses listed below. Eligible candidates must be accepted and enrolled in a degree seeking program at Keiser University, Melbourne Campus.
