Hand sanitizer or handwashing station required at entrance. Plan for disposable PPE's including trash cans at the entrance with touchless lids. Clear visible markings or barriers to ensure 6 ft distance. One dedicated staff member in dining room and kitchen to ensure social distancing is being followed. Records must be kept on new sanitation procedures, closing procedure in case of exposure, cleaning task checklist and daily employee screening.
