Broward	Restaurants and food establishments will have to close dining rooms by midnight until 5 a.m. Establishments must restrict ordering & consumption for on-premise to only at a table or standing at an assigned table or assigned area. Drive-through, pick-up, take-out of food or alcohol allowed during these hours. Restaurants allowed to have over 50% indoor capacity only if tables are 6 ft apart, no more than 6 in a party at one table. Bar seating allowed with 6ft distancing between parties. All persons while working in any capacity of an establishment shall wear a face covering. Adequate supplies available to support healthy hygiene for employees and customers. Must use pre-rolled bags or wraps of utensils and eliminate table presets. Touchless payment systems, avoid hand to hand contact. Provide physical guides indicating social distancing and safety protocols. Employees are to be limited in shared spaces. Child or adult gaming and play spaces remain closed. No buffets or salad bars allowed. No self serve-items to be out such as cut fruit, unwrapped utensils, and unwrapped straws. Restrooms must be sanitized no less than every hour. Implement and train all employees on new protocol and frequency of sanitizing surfaces. Daily employee health screening. Signs required to be posted for customers and employees. (Attachment 2: All establishments serving food or alcohol must be followed - Updated 10/16) Locations that sell alcohol only may operate at 50% indoor capacity with social distancing for tables and chairs.
