Must use pre-rolled bags or wraps of utensils and eliminate table presets. Touchless payment systems, avoid hand to hand contact. No buffets or salad bars allowed. No self serve-items to be out such as cut fruit, unwrapped utensils, and unwrapped straws. Restrooms must be sanitized no less than every hour.
