Adequate supplies available to support healthy hygiene for employees and customers. Must use pre-rolled bags or wraps of utensils and eliminate table presets. Touchless payment systems, avoid hand to hand contact. Provide physical guides indicating social distancing and safety protocols. Employees are to be limited in shared spaces.
