Child or adult gaming and play spaces remain closed. No buffets or salad bars allowed. No self serve-items to be out such as cut fruit, unwrapped utensils, and unwrapped straws. Restrooms must be sanitized no less than every hour. Implement and train all employees on new protocol and frequency of sanitizing surfaces. Signs required to be posted for customers and employees.
