Take out and delivery allowed. On-premise consumption only allowed for the hours of 6 a.m. to midnight. Bars with counter service can reach 50%. Required signs posted for customers and employees very visible. Staff is to be limited in all working areas, face coverings required, social distancing and gloves for all involved in direct food preparations. Recommended that FOH staff does not enter BOH when possible. No self-service of any kind, no buffets, no salad bars.
