Or partian between bar guest if unable to distance. All persons while working in any capacity of an establishment shall wear a face covering. Adequate supplies available to support healthy hygiene for employees and customers. Must use pre-rolled bags or wraps of utensils and eliminate table presets. Touchless payment systems, avoid hand to hand contact. Provide physical guides indicating social distancing and safety protocols. Employees are to be limited in shared spaces. Child or adult gaming and play spaces remain closed. No buffets or salad bars allowed. No self serve-items to be out such as cut fruit, unwrapped utensils, and unwrapped straws.
